## A BRIEF REVIEW ON SOME FRACTIONAL POINT PROCESSES

In this paper we consider some fractional versions of classical pure birth, pure death and birth and death processes.

The classical non-linear pure birth process is a model of an expanding population where the number of components at time t is a random point process N(t), t > 0, with birth rates  $\lambda_k, k \ge 1$ .

The state probabilities

$$p_k(t) = \Pr\{N(t) = k \mid N(0) = 1\}, \ k \ge 1, t > 0, \tag{1}$$

satisfy the difference-differential equations

$$\begin{cases} \frac{d}{dt} p_{k} = \lambda_{k-1} p_{k-1} - \lambda_{k} p_{k}, & k \ge 1, \\ p_{k}(0) = \begin{cases} 1, & k = 1, \\ 0, & k \ge 2. \end{cases} \end{cases}$$
 (2)

In the fractional version of (2), we replace the time derivative with the fractional derivative

$$\frac{d^{\nu}}{dt^{\nu}}f(t) = \frac{1}{\Gamma(1-\nu)} \int_{0}^{t} \frac{f'(s)}{(t-s)^{\nu}} ds, \qquad 0 < \nu < 1,$$
 (3)

called Caputo or Dzhrbashyan-Caputo derivative.

We have shown, in Orsingher-Polito (2010) that, for the fractional birth process  $N^{\nu}(t), t > 0$ , the solution to

$$\begin{cases} \frac{d^{v}}{dt^{v}} p_{k} = \lambda_{k-1} p_{k-1} - \lambda_{k} p_{k}, & k \ge 1, \\ p_{k}(0) = \begin{cases} 1, & k = 1, \\ 0, & k \ge 2. \end{cases} \end{cases}$$
(4)

has the form

$$p_{k}^{v}(t) = \begin{cases} \Pi_{j=1}^{k-1} \lambda_{j} \sum_{m=1}^{k} \frac{E_{v,1}(-\lambda_{m}t^{v})}{\Pi_{l=1,l\neq m}(\lambda_{l}-\lambda_{m})}, & k > 1, \\ E_{v,1}(-\lambda_{1}t^{v}), & k = 1 \end{cases}$$
(5)

where

$$E_{v,1}(x) = \sum_{k=0}^{\infty} \frac{x^k}{\Gamma(vk+1)}, \qquad x \in \Re, v > 0,$$
 (6)

is the Mittag-Leffler function.

For v = 1, we recover, from (5), the classical distribution of the non-linear pure birth process.

We were able to show that, between  $N^{v}(t)$  and N(t), holds the following subordination relation:

$$N^{\nu}(t) = N(T_{2\nu}(t)), \qquad t > 0,$$
 (7)

where  $T_{2\nu}(t)$ , t > 0, is a random process possessing a law satisfying the fractional diffusion

equation

$$\begin{cases} \frac{\partial^{2v}}{\partial t^{v}} u = \frac{\partial^{2}}{\partial x^{2}} u, & 0 < v \le 1, t > 0, x > 0, \\ u(x,0) = \delta(x), & u_{t}(x,0) = 0, & for 1/2 < v \le 1, \\ u_{x}(0,t) = 0. & \end{cases}$$
(8)

For v = 1/2,  $T_1(t)$  is a reflecting Brownian motion so that we can write

$$N^{\frac{1}{2}}(t) = N(|B(t)|), t > 0. (9)$$

The distributional structure (5) is complicated, and some special cases must be considered in order to illustrate what is going on. For the linear case, that is when  $\lambda_k = \lambda k, \lambda > 0$ , the equations governing the state probabilities become

$$\begin{cases} \frac{d^{\nu}}{dt^{\nu}} p_{k} = \lambda(k-1)p_{k-1} - \lambda k p_{k}, & k \ge 1, \\ p_{k}(0) = \begin{cases} 1, k = 1, \\ 0, k \ge 2, \end{cases} \end{cases}$$
(10)

and we obtain that

$$p_{k}^{\nu}(t) = \sum_{j=1}^{k} {k-1 \choose j-1} (-1)^{j-1} E_{\nu,1}(-\lambda j t^{\nu}), \qquad k \ge 1.$$
 (11)

For 
$$v=1$$
, the distribution (11) becomes the geometric distribution 
$$p_k^1(t)=e^{-\lambda t}(1-e^{-\lambda t})^{k-1}, \qquad k\geq 1. \tag{12}$$
 Linearity permits us to obtain, in a relatively simple form, the probability generating function

$$\begin{cases}
EN^{\nu}(t) = E_{\nu,1}(\lambda t^{\nu}), \\
VarN^{\nu}(t) = 2E_{\nu,1}(2\lambda t^{\nu}) - E_{\nu,1}(\lambda t^{\nu}) - E_{\nu,1}^{2}(\lambda t^{\nu}).
\end{cases}$$
(13)

We can see that, for 0 < v < 1, the mean number of components of the population increases faster and faster, as v decreases in this interval.

Something similar to what we present here, happens for the pure death process.

We have initially a population consisting of  $n_0$  individuals, subject to non-linear death rates  $\mu_k$ .

While in the pure birth case (fractional or not), the population expands without restriction, in the pure death case, it is condemned to extinction.

The state probabilities

$$\hat{p}_{k}^{v}(t) = \Pr\{M^{v}(t) = k \mid M^{v}(0) = n_{0}\}, \qquad 0 \le k \le n_{0}, t > 0,$$
(14)

satisfy the fractional equations

$$\begin{cases} \frac{d^{\nu}}{dt^{\nu}} \, \hat{p}_{k} = \mu_{k+1} \hat{p}_{k+1} - \mu_{k} \, \hat{p}_{k}, & k \ge 1, \\ \hat{p}_{k}(0) = \begin{cases} 1, & k = n_{0}, \\ 0, & 0 \le k < n_{0}. \end{cases}$$
(15)

The solution to (15) becomes

$$\hat{p}_{k}^{v}(t) = E_{v,1}(-\mu_{n_0}t^{v}), \qquad k = n_0,$$
(16)

$$\hat{p}_{k}^{v}(t) = \prod_{j=k+1}^{n_{0}} \mu_{j} \sum_{m=k}^{n_{0}} \frac{E_{v,1}(-\mu_{m}t^{v})}{\prod_{k=k}^{n_{0}} \mu_{m}(\mu_{k} - \mu_{m})}, \qquad 0 < k < n_{0},$$
(17)

$$\hat{p}_{k}^{v}(t) = 1 - \sum_{m=1}^{n_{0}} \prod_{h=1, h \neq m}^{n_{0}} \left( \frac{\mu_{h}}{\mu_{h} - \mu_{m}} \right) E_{v,1}(-\mu t^{v}), \qquad k = 0, n_{0} > 1.$$
 (18)

In the very special case where  $n_0 = 1$ , the extinction probability becomes

$$\hat{p}_0^{\nu}(t) = 1 - E_{\nu,1}(-\mu_1 t^{\nu}). \tag{19}$$

Also, in this case, linearity  $(\mu_k = \mu k)$  simplifies the form of the state probabilities, which become

$$\hat{p}_{k}^{\nu}(t) = \binom{n_{0}}{k} \sum_{r=0}^{n_{0}-k} \binom{n_{0}-k}{r} (-1)^{r} E_{\nu,1}(-(k+r)\mu t^{\nu}), \qquad 0 \le k \le n_{0}.$$
 (20)

For v = 1, we extract from (20), the classical pure death distribution (Binomial):

$$\hat{p}_k^1(t) = \binom{n_0}{k} e^{-\mu kt} (1 - e^{-\mu t})^{n_0 - k}, \qquad t > 0, \ 0 \le k \le n_0.$$
 (21)

The mean value of the fractional linear pure death process  $M^{\nu}(t), t > 0$ , is

$$EM^{\nu}(t) = n_0 E_{\nu,1}(-\mu t^{\nu}), \tag{22}$$

and therefore it steadily decreases as t increases.

Another special case of death process is the sublinear fractional pure death process, where the death rates have the form

$$\mu_k = \mu(n_0 + 1 - k), \qquad 0 \le k \le n_0.$$
 (23)

In this case, the death intensities of individuals increases as the population size decreases. We are able to prove that the fractional sublinear death process  $\tilde{M}^v(t), t>0$ , has distribution

$$\Pr\left\{\widetilde{M}^{\nu}(t) = k \mid \widetilde{M}^{\nu}(0) = n_0\right\} = \sum_{l=0}^{n_0-k} \binom{n_0-k}{l} (-1)^l E_{\nu,1}(-\mu(l+1)t^{\nu}), \qquad 1 \le k \le n_0 \quad (24)$$

The extinction probability, in the sublinear case, is given by

$$\widetilde{p}_{0}^{v}(t) = \sum_{l=0}^{n_{0}} \binom{n_{0}}{l} (-1)^{l} E_{v,1}(-l\mu t^{v}).$$
(25)

Furthermore, by summing up the probabilities (24), we get that

$$\sum_{k=1}^{n_0} \tilde{p}_k^{\nu}(t) = 1 - \sum_{k=0}^{n_0} \binom{n_0}{k} (-1)^k E_{\nu,1}(-k\mu t^{\nu}), \tag{26}$$

and thus (24) and (25) form a genuine probability distribution. Curiously enough, the mean value in the sublinear death process, has a rather complicated structure, since it has the following form:

$$E\widetilde{M}^{v}(t) = \sum_{k=1}^{n_0} {n_0 + 1 \choose k+1} (-1)^{k+1} E_{v,1}(-\mu k t^{v}), \qquad 0 < v \le 1, \ t > 0.$$
 (27)

Between the linear birth process  $N^v(t), t > 0$ , and the sublinear death process  $\tilde{M}^v(t), t > 0$ , there are some unexpected analogies, for example:

$$\Pr\{N^{\nu}(t) = k \mid N^{\nu}(0) = 1\} = \Pr\{\widetilde{M}^{\nu}(t) = n_0 + 1 - k \mid \widetilde{M}^{\nu}(0) = n_0\}, \qquad 1 \le k \le n_0,$$
 (28)

and

$$\Pr\{N^{\nu}(t) > n_0 \mid N^{\nu}(0) = 1\} = \Pr\{\widetilde{M}^{\nu}(t) = 0 \mid \widetilde{M}^{\nu}(0) = n_0\}$$
(29)

If we assume that the population is simultaneously subject to births and deaths, the analysis of the fractional counterpart of the classical process becomes more complicated; therefore we restrict ourselves only to the fractional linear birth and death process.

The state probabilities, in this case, are subject to the governing equations

$$\frac{d^{\nu}}{dt^{\nu}}p_{k} = -(\lambda + \mu)kp_{k} + \lambda(k-1)p_{k-1} + \mu(k+1)p_{k+1}, \qquad k \ge 0,$$
(30)

and

$$p_k(0) = \begin{cases} 1, & k = 1, \\ 0, & k \neq 1. \end{cases}$$
 (31)

For v = 1, we obtain the well-known distribution

$$\overline{p}_{k}^{1}(t) = (\lambda - \mu)^{2} e^{-(\lambda - \mu)t} \frac{(\lambda (1 - e^{-(\lambda - \mu)t}))^{k-1}}{(\lambda - \mu e^{-(\lambda - \mu)t})^{k+1}}, \qquad k \ge 1, t < 0, \mu \ne \lambda.$$
(32)

For  $\mu = \lambda$ , we have a very fine distribution which becomes

$$\overline{p}_{k}^{1}(t) = \frac{(\lambda t)^{k-1}}{(1+\lambda t)^{k+1}}, \qquad k \ge 1, t > 0.$$
(33)

The extinction probabilities, play a fundamental role, and take the form

$$\overline{p}_{0}^{1}(t) = \begin{cases}
\frac{\lambda t}{1 + \lambda t}, & \lambda = \mu, \\
\frac{\mu - \mu e^{-t(\lambda - \mu)}}{\lambda - \mu e^{-t(\lambda - \mu)}}, & \lambda \neq \mu.
\end{cases} \tag{34}$$

What is remarkable about (34) is that they solve Riccati equations. In the case  $\lambda = \mu$ , this equation has the form

$$\frac{d}{dt}p_0 + 2\lambda p_0 = \lambda + \lambda p_0^2. \tag{35}$$

As must be expected, all these distributions in the fractional case, have a much more complicated structure. The extinction probabilities, in the three cases  $\lambda > \mu, \lambda < \mu$ , and  $\lambda = \mu$ , become

$$\overline{p}_{0}^{v}(t) = \frac{\mu}{\lambda} - \frac{\lambda - \mu}{\lambda} \sum_{m=1}^{\infty} \left(\frac{\mu}{\lambda}\right)^{m} E_{v,1}(-m(\lambda - \mu)t^{v}), \qquad \lambda > \mu,$$
 (36)

$$\overline{p}_{0}^{v}(t) = 1 - \frac{\mu - \lambda}{\lambda} \sum_{m=1}^{\infty} \left(\frac{\lambda}{\mu}\right)^{m} E_{v,1}(-m(\mu - \lambda)t^{v}), \qquad \lambda < \mu,$$
(37)

$$\overline{p}_{0}^{v}(t) = 1 - \int_{0}^{\infty} e^{-w} E_{v,1}(-\lambda t^{v} w) dw, \qquad \lambda = \mu.$$
 (38)

First of all, we note that, for v=1, we get from the above distribution, the classical extinction probabilities of the linear birth and death process. This is almost immediate for  $\lambda=\mu$ , since  $E_{1,1}(-x)=e^{-x}$ . Furthermore, we note that, for  $t\to\infty$ , the extinction happens with probability one for  $\mu \geq \lambda$  while, for  $\mu < \lambda, \lim_{t\to\infty} \overline{p}_0^v(t) = \mu/\lambda$ , as in the classical case.

For the sake of completeness, we give also the state probabilities for k > 0. For  $\lambda > \mu$  we have that

$$\overline{p}_{k}^{\nu}(t) = \left(\frac{\lambda - \mu}{\lambda}\right) \sum_{l=0}^{\infty} {l+k \choose l} \left(\frac{\mu}{\lambda}\right)^{l} \sum_{r=0}^{k-1} (-1)^{r} {k-1 \choose r} E_{\nu,1}(-(l+r+1)(\lambda - \mu)t^{\nu}), \quad (39)$$

while, for  $\lambda < \mu$ ,

$$\overline{p}_{k}^{v}(t) = \left(\frac{\lambda}{\mu}\right)^{k-1} \left(\frac{\mu - \lambda}{\mu}\right) \sum_{l=0}^{\infty} {l+k \choose l} \left(\frac{\lambda}{\mu}\right)^{l} \sum_{r=0}^{k-1} (-1)^{r} {k-1 \choose r} E_{v,1}(-(l+r+1)(\mu - \lambda)t^{v}). \tag{40}$$

The case  $\lambda = \mu$  is particularly interesting because, in this case, the state probabilities can be expressed in terms of the probability of extinction

$$\Pr\left\{\overline{N}^{\nu}(t) = k\right\} = \overline{p}_{k}^{\nu}(t) = (-1)^{k-1} \frac{\lambda^{k-1}}{k!} \cdot \frac{d^{k}}{d\lambda^{k}} \left[\lambda(1 - \overline{p}_{0}^{\nu}(t))\right] \qquad k \ge 1.$$

$$(41)$$

Some direct information on the behaviour of the fractional linear birth and death process, can be obtained from the moments. The mean value is

$$E\overline{N}^{\nu}(t) = \begin{cases}
E_{\nu,1}((\lambda - \mu)t^{\nu}), & t > 0, \ \lambda \neq \mu, \\
1, & \lambda = \mu,
\end{cases} \tag{42}$$

and the variance, for  $\lambda \neq \mu$ , reads

$$Var \overline{N}^{\nu}(t) = \frac{2\lambda}{\lambda - \mu} E_{\nu,1}(2(\lambda - \mu)t^{\nu}) - \frac{\lambda + \mu}{\lambda - \mu} E_{\nu,1}((\lambda - \mu)t^{\nu}) - E_{\nu,1}^{2}((\lambda - \mu)t^{\nu}), \quad (43)$$

while, for  $\lambda = \mu$ , the variance is

$$Var\overline{N}^{\nu}(t) = \frac{2\lambda t^{\nu}}{\Gamma(\nu+1)}.$$
(44)

From (42) and (43), for v = 1, we obtain the classical expressions of the mean and variance of the linear birth and death process. For example, when v = 1,

$$Var\overline{N}^{1}(t) = \begin{cases} \frac{\lambda + \mu}{\lambda - \mu} e^{t(\lambda - \mu)} (e^{t(\lambda - \mu)} - 1), & \lambda \neq \mu, \\ 2\lambda t & \lambda = \mu. \end{cases}$$
(45)

This shows that, for  $\lambda \ge \mu$ , the variance increases as t grows to infinity.

As in the previous cases, the subordination relation between the classical linear birth and death process  $\overline{N}^1(t)$ , t > 0, and its fractional version  $\overline{N}^v(t)$ , t > 0, holds and we can write

$$\overline{N}^{\nu}(t) = \overline{N}^{1}(T_{2\nu}(t)), \quad t > 0, \tag{46}$$

and this has been the main mean of investigation, permitting us to evaluate all the probabilities presented here.
